Expression of Interest in sealed covers are invited from reputed Surveyors / Consultants / Operation Research firms / NGOs and such organizations / Institutions to conduct monitoring / assessment study of the implementation of the electrification through non-conventional energy sources in respect of 197 remote villages covering the districts of Gajapati, Keonjhar, Sundergarh and Kalahandi in the state under RVEP-2006-07. The offers should reach this office on or before 3 P.M. of 31.10.08 and will be opened on the same day at 4 P.M. in presence of the tenderers or their authorised representatives who may like to be present. The scope of work will cover as follows.

- 1.Village wise verification of elctrification works taken up under RVEP-2006-07. The list of villages are enclosed here with.
2. Functionality of the systems installed under electrification.

The terms and conditions are as follows

1. The firm must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skill among staff etc).
2. The interested firms may obtain further information if any from the Support Service Division, OREDA on any working day.
3. The firm shall submit the verification report in respect of electrified villages furnished by OREDA and certify that the village has been electrified through non-conventional sources of energy.
4. The verification report should be submitted with in 30 days of issue of work order. The reports may also be submitted phase wise on verification but total work should be completed with in the above time limit.
5. Rates may please be quoted on per village basis. Taxes if any may be indicated separately. The rates should be firm and fixed.
6. Conditional quotations will not be accepted.
7. Payment will be made on acceptance of the verification report . Bills in triplicate along with valid Tax Clearance Certificate must be submitted for release of payment.
